- Advocacy Update / Legislative Report: (Amanda Sines)
 - Very active month in December battling proposal to consolidate several boards into 3 boards that would put counselors on a Behavioral Health board. Under the original proposal, counselors weren't guaranteed a seat on the new board. Changes were made after our advocacy efforts to give counselors a seat but the name was then changed to the State Behavioral Health and Social Work board – which raised a new set of concerns. We were able to get letters to every representative. We do expect to see the item again – particularly in the Governor's proposed budget. We will

- take action at that time. Thank you for all of your efforts to contact your legislators! Your efforts paid off.
- Expanding coverage for Autism services was passed in HB350 during the lame duck session. We suggested changes this time last year to include service providers to include counselors. Originally was supposed to apply to anyone under age 21. Now only applies ages 14yo and under. New ruling now applies to all state plans.
 - Discussion on requiring cultural competency CE in the context of SB 332 (Infant Mortality Legislation). You can find a summary of the issue in the legislative report. We oppose efforts to legislate how we educate counselors.
 - Looking ahead: Board consolidation issue (as discussed above), state budget (expected to be a tight budget; ongoing issues re: how state is handling managed care funds)
 - Planning for 2017 Advocacy Day is underway. Currently scheduled for April 26th at the Riffe Center in downtown Columbus. Details and Save the Date will be coming soon. The event will be scheduled in the heart of budget discussions so we will have specific topics we want to discuss.
 - Telemedicine Rule through Ohio Dept of Medicaid is being edited. Amanda has reached out to learn more about the schedule & the appropriate time for us to voice our concerns. Currently, only certain professions can provide telemedicine. Our interest is being sure that counselors are included as approved service providers.
 - Currently a lawsuit pending to challenge a health transparency law. Requires that all providers provide patients with a good faith estimate of what their services will cost when providing non-emergency services. Study committee & report were supposed to be convened. Those steps were not completed. The law has been delayed until the lawsuit can be resolved.
 - Counseling Journal (Faii Sangganjanavanich)
 - Preparing for April 2017 issue. Two articles in place. Looking for one more to complete the issue.
 - Significant increase in submissions this month.
 - CAIT (Jennifer Scott)
 - This Taskforce was formed as result at earlier EC meeting to discuss how we communicate with our constituents.
