ISSUES IN PROGRESS

- House Bill 443 -- Ohio Mental Health Parity and Equity Act (MHPAEA)
 - Primary Sponsors: Rep. Phil Plummer (R-Dayton) and Rep. Allison Russo (D-Upper Arlington)
 - Aim: Align state law with current federal law; raise awareness among individuals, families, and employers about their rights and responsibilities under the law; and facilitate greater implementation and enforcement...
 - Goal: Provide greater transparency and accountability that results in expanded access to mental health and addiction treatment services for Ohioans
 - Bill Status: Introduced

Senate Bill 246 -- Require Occupational Licensing of Out-of-State Licensees

- Primary Sponsors: Sen. Kristina Roegner (R-Hudson) and Sen. (Rob McColley (R-Napoleon)
- Aim: Create a process for all out-of-state applicants practicing a profession to get a license in Ohio without having to meet additional requirements or demonstrate competency for Ohio's standards.
- Goal: Spur economic development in Ohio and make Ohio more attractive to work in the state
- Bill Status: In Senate Committee (12/4/19)

House Bill 323 -- Grant Psychologists Prescriptive Authority

- Primary Sponsors: Don Manning (R-New Middletown)
- Aim: Would allow psychologists to prescribe psychotropic medications, should the meet the following criteria:
 - are a doctoral-level psychologist, license d in the state of Ohio;
 - have completed a master's degree in Clinical Psychopharmacology;
 - have completed 700 hours of clinical supervision, 350 of which are under a psychiatrist;
 - have entered into and maintain a collaborative relationship with a statelicensed physician;
 - and have applied to the State Psychology Board and adhere to all relevant rules/regulations governing the prescription of medications in Ohio.
- Goal: Aid in the shortage of psychiatrists and bridge the gap between clients and effective medication treatment/management to supplement mental and behavioral health treatment.
